

Unbelievably true, it has been fifty long years of milestone of success and excellence since we opened our doors. This 2017, we look back to the challenges of our past, assess our current standing and set forth another big dream. Then and now, our Tagum Cooperative has always played a crucial role in improving our lives and promoting social transformation.

From a humble beginning - a church-based cooperative, consisting only of 38 founding members with a startling P80 share capital in 1967. We were then a small organization with very limited financial services. Who would have thought that the visionary steps of our predecessors escalated over time into prominent leap, from simple self-serving banking service to now indispensable social function? Without doubt, our deeply-rooted and unshakeable mission of improving our community's and our own socioeconomic and spiritual lives indeed has led our Tagum Cooperative to its present crowning glory.

Amidst the challenges of economic reverses, members and management conflicts, government and political pressures, and other fortuitous events, we relentlessly thrived over time. As we watched other organizations and financial institutions alike zestfully emerged and vanished in no time, we stood strong and firm without faltering of support. Throughout the years, we went through difficult times and encouraging moments. Nevertheless, no stone was left unturned as we learned from all these experiences, which learning we capitalized to purge stumbling blocks on our way to success. We consider difficulties as challenges, problems as opportunities, losses as goals and the affirmative results as our inspiration, the problems as opportunities, the loss as goal and the affirmative results as our inspiration.

From then a highly vulnerable organization, now we are a formidable social institution. We have grown exponentially in numbers and in investments. From 38 members, we are now close to 77,000 members, excluding the nearly 52,000 users, at present. We had no asset then except

our talents, but now we have an astonishing P4.372 Billion worth of assets as of December 2016, and growing at an unprecedented rate. From then P80, we put up P 1.416 Billion total share capital as of December 2016, over 25% higher than the previous year. We constantly surpassed our yearly target as we now have a P326.05 Million net surplus. In keeping with our growth, our products and services have become comprehensive, from savings and loan service to insurance and funeral services. We also erected a fully functional Budgetel to provide for low-cost transient accommodation services to our clientele. More importantly, from a single local main unit in Tagum City, we have established 11 branches across Davao Region and more upcoming in other parts of Mindanao.

It is axiomatic that pure gold is tested with fire. More than a test, the fire of our unwavering commitment and utmost trust and confidence is the very reason that our cooperative turned gold today. Should we turn diamond or make another fifty years more? The future rests upon no one but ourselves by keeping our fire burning, radiating light to others and giving warmth to one another. We may have accomplished so much as evidenced by the numerous recognition we received from various renowned award giving bodies; local, regional, national and even international cooperative networks. To highlight, we are branded with Silver A-1 Competitive Choice for Excellence in Service and Soundness (ACCESS) Certificate for two consecutive times given by the Association of Asian Confederation of Credit Unions (ACCU) in 2015 at Bangkok, Thailand and in 2016 at Incheon, South Korea, However, we cannot rest on our laurels because we still have more rooms for improvements and a long way to go for our future generations.

Our culture of success and excellence emanated from no less than our TAGUM COOP core values deeply encrypted in our consciousness—Trustworthiness, Accountability, God-Centered, Unity, Member-friendly, Competence, Optimism, Openness, and Passion. There may be no exact or fixed formula of success, but to us these core values complexed with each member's full trust, confidence and financial discipline have paved our way to this year's golden harvest.

From then a simple economic enterprise to now outstanding landmark of excellence, becoming an exemplary empire in financial cooperation soon is not an elusive dream. We envisioned our cooperative to be an icon of trust and excellence in social and financial services, and with the way we put things in place, we surely are traversing the right direction. At present, we are admired for our revolutionary strategies, which not only amplified our internal economy but also in one way or another have greatly contributed to achieving inclusive growth and poverty alleviation efforts in our country.

In essence, our cooperative exists so that we could help one another to work together and move forward in a collective way, while observing mutual respect and considering everyone's welfare. We, however, embraced a more sensitive and passionate perspective as we put God as the center of all. More than the assets and profits, we value lives and dreams. 



NUMBER OF LOANS ACTED AND RATIFIED PER LOAN TYPE




AMOUNT OF LOANS ACTED AND RATIFIED PER LOAN TYPE

This is the result of the continued support, dedication and commitment of the members, officers and management of Tagum Cooperative.

INFORMATION

For CY 2015-2016, in the Office of the Board of Directors there were three (3) positions due for election. In the AUDIT COMMITTEE, only one (1) position was due for election while in the ELECTION COMMITTEE the same one (1) position was subject for election.

The Members-in-Good Standing (MIGS) of Tagum Cooperative as of December 31, 2016 reached to Forty Two Thousand One Hundred Ninety Seven (42, 197) compared to year 2015 in which the total number of MIGS was Thirty Six Thousand Two Hundred Sixty Seven members (36,267).

The Election Committee together with the assistance of the Information and Communication Technology (ICT) Department continues to refine the program and the

processing of the Electronic Voting to deliver a harmonious election process. Moreover, the Election Committee continued to educate the Tagum Coop members about the E-Voting process with the support of the Education Committee (EdCom) mainly during Ownership Meetings.

Our priority for 2017 is the crafting of the Rules, Procedures and Guidelines for the District Meetings and Annual Representative Assembly Meetings which is set to be implemented this 2018.

CONCILIATION-MEDIATION COMMITTEE (CMC) REPORT

To Our Valued Cooperators.

Pursuant to Article 137 of Republic Act 9520, otherwise known as the Cooperative Code of 2008, reinforced by Republic Act 9285 known as the Alternative Dispute Resolution act of 2004 and in compliance to Section 1 – a and b of Article X of the Tagum Cooperative Constitution and By-Laws, the Conciliation-Mediation Committee is tasked to facilitate the settlement of conflicts/controversy arising between and among members of the Board of Directors, Committees, Officials and Individual members of the cooperative and the same those arising from Ioan obligations contracted by the members with Tagum Cooperative and other analogous cases shall be brought directly by any party involved to the Conciliation and Mediation Committee for settlement. If no settlement is agreed upon, any party may elevate the same before the regular courts of competent jurisdiction.

Clothed with this mandate, the committee for the past six years had received a total of 2,692 requests for mediation emanating from the 11 TC branches all for the collection of sum of money from our cooperative member-borrowers who failed to pay their loan obligations. These requests for mediation involve a considerable amount that totals to P100,239,566.00. And out of this figure 53.68% or P 53,811,634.43 was collected as a result of the series of mediation conferences conducted by the committee officers.

For 2016, the Committee received 148 requests for mediation and had successfully facilitated the settlement of 64 cases which resulted to the delinquent member-borrowers loan payments of P1,632,969.59 or a 12.48% against the total amount of collectibles. It has been noted that eight (8) of those mediated cases were fully paid by the TC member. Seven (7) members after receipt of mediation notices voluntarily settled their accounts, twelve (12) cases were subjected for filing of case while, one (1) already filed in court. While sixty-six (66) did not appear for mediation conference. Their non-appearance perhaps can be attributed to the following reasons that were gathered from some of the member-borrowers in the course of our interaction with them during the mediation process:

That, they have the understanding that if they will not pay their loans, it is automatic that their share capital will off-set their balances; that, they fear they will be made to pay in full the amount indicated in the loan statement and most

of them do not really know what mediation is all about.

With this information, the Committee recommends that our cooperative members must be oriented on what mediation is all about. They need to know that, Mediation is a process where a trained neutral third party facilitates a negotiation between parties to help them reach a voluntary, mutually, satisfying agreement. It is recognized and accepted by legal practitioners as an effective alternative in resolving cases or conflicts outside the judiciary or litigation process. It promises a speedy, inexpensive, restorative and harmonizing outcome. Because the only objectives of Mediation are: to provide an opportunity of disputing parties to talk and hear out each other; and try to make the interests of both parties meet to come up with a win-win solution; giving them the freedom to make their own arrangements to resolve their disputes. The Committee can also mediate individuals/non-members, provided, the issue is the interest of the cooperative.

For 2017, the Conciliation-Mediation Committee Officers assures the continuous mediation services and ensures that the parties leave the resolution process as winners.

Lastly, we wish to thank you for your trust and together let us celebrate our cooperative's 50th Anniversary!



ETHICS COMMITEE REPORT

The Ethics Committee is a vital component in the operations of every Cooperative; the body preserves the positive motivation and controls on the circumstances that involve the morals, decorum and good governance among cooperative leaders, employees and members. The body also promotes the enforcement of one's rights and assumption of responsibilities through the. proper implementation of the cooperative's By Laws, Policies and Procedures. In the case of Tagum Cooperative, the work of the committee is guided by the Code of Ethics and Good Governance Manual duly approved by the Joint Officers of the Cooperative and ratified/confirmed by the General Assembly.

For operating year 2016, the Ethics Committee has made significant contributions in support to Tagum Cooperative's thrust to promote transparency and good governance. During the first month of the term, the committee conducted an Orientation of the approved Ethics Manual to the staff of Tagum Cooperative- San Francisco Branch, the only Branch that was not included during the 2015 series of information dissémination drive.During the conduct of the orientation, comments and recommendations were solicited to further enhance the Ethics Manual and ensure that the same is appropriately enforced and implemented. During 2016, no violations related to the ethical requirements among the cooperative leaders and employees were recorded.

Moreover, the committee has initially prepared the Ethics and Good Governance Primer that is reader-friendly, understandable with clear and direct to the point statements that will uphold clarity, guidance and comprehension of the provisions stipulated in the manual. The said primer will considerably support the Committee's information, dissemination efforts to all Officers, Key Personnel, Employees and Members across all Tagum Cooperative Branches.

As a body that monitors the compliance of the Code of Ethics and Good Governance, the Committee has continually revisited and evaluated the Manual and at the same time conducted a review on certain provisions of the Code of Ethics Manual which are also stipulated in the Employee's HRD Manual. The Committee observed some inconsistencies and conflicts which it has duly presented to the management for review and clarification along with its corresponding recommendations and measures to be undertaken. Such review also resulted in recommending to the Board of Directors for the creation and appointment/designation of the members of the Committee on Decorum and Investigation

Throughout the current year term, the Committee coordinated with other committees particularly the Audit Committee for the conduct of initial investigation on the various complaints involving the alleged failure of some employees and officers to uphold ethical standards and good governance. For this term, the committee has answered one (1) inquiry from the Audit Committee asking for opinion from the Ethics Committee on the provisions of conflict of interests and the observance of proper decorum of TC officers during meetings particularly on the issue involving their relatives. The findings and recommendation as well as the appropriate actions to be taken were duly submitted to the Board of Directors.

The Ethics Committee is committed and enthusiastic in promoting good governance and high ethical standards in the operation of Tagum Cooperative which is duly supported by the Board of Directors and the Management and Staff, thus contributing to this year's significant accomplishments.

The Committee wishes more power and success to Tagum Cooperative as we celebrate its 50th Golden Annual General Assembly. Mabuhay and God Speed!!!

Section 4. Rights of a Member-In-Good-Standing

Every member in good standing shall have the following rights:

c). Seek any elective position, subject to the provisions of Section 11, Article III of these Bv-laws:

ARTICLE III ADMINISTRATION

Section 2.A The Representative Assembly

- 1. District. A District shall consist of one or more barangays, municipalities, cities and provinces as determined by the Board Of Directors. Likewise, as determined by the Board of Directors, The Main Office may be divided into North District, South District, East District, West District and/or such other districts, as the Board of Directors shall create and establish, which shall likewise include all the barangays, municipalities, cities and provinces within its jurisdiction. In all cases, a district must at least have a minimum of two hundred (200) Regular Members.
- 2. Quorum in a District Meeting. At least twenty five percent (25%) of the Regular Members who are bonafide residents of the barangays, municipalities, cities and provinces which are within the jurisdiction of a district for at least six months prior to the date of the district election and Members In Good Standing in the said district, shall constitute a quorum. Only Regular Members who are Members in Good Standing (MIGS) are entitled to vote and be voted upon. Eighty five (85) days before the date of the district election, no Regular Member is allowed to transfer to another district and to vote or be voted thereon.
- 6. Election of District Representatives. Regular District Meeting wherein the election of the District Representatives (DR) and The District Election Deputies shall be conducted, may be held not later than sixty (60) days prior to the date of the Regular Annual Representative Assembly Meeting (ARAM). However, the Board of Directors at its discretion, shall set the date and time either simultaneously or sequentially, of each and every Regular District Meeting. The District Representative/s and District Election Deputies shall be elected by secret balloting during the Regular District Meeting by the Regular Members of the district, who are likewise Members In Good Standing.
- 7. Term of Office of a District Representative. The Term of Office of a District Representative shall be two (2) Years, Which shall commence on the first Regular Annual Representative Assembly Meeting. The Regular District Meeting wherein the election shall be conducted for all the various Districts Of Tagum Cooperative, an a particular date and time shall be determined by the Board Of Directors. No District Representative shall serve for more than three (3) Consecutive Terms. Moreover, each and every District Representative must maintain his/her monthly "MEMBER IN GOOD STANDING (MIGS)" status all through-out his/her Term Of Office.
- 8. Failure of the District to elect District Representatives. In case the District failed to elect its District Representative/s during the Regular District Meeting wherein the election is conducted, the right to send its District Representative/s to a particular Representative Assembly Meeting shall be deemed waived, and such waiver shall be effective until the next regular district election. Hence, no District Election nor any type of district activity shall be conducted. Whatsoever, to elect district Representatives during such period of waiver.
- 10. Any District Representative during a District Meeting called for the purpose, shall be removed by a vote of three-fourths (3/4) of the entire Regular Members who are Members In Good Standing present and constituting a quorum, on the following grounds:
- A) Failure to attend the immediate preceding Representative Assembly Meeting for unjustifiable reason;
- B) non-performance of any functions and responsibilities stated in the by-laws;
- C) Any Violation of the provisions of RA 9520, the By-Laws of Tagum Cooperative and other issuances of the Cooperative Development Authority (CDA);
- D) Any acts or omissions inimical or prejudicial to the Interest of Tagum Cooperative.

Section 4. Rights of a Member-In-Good-Standing

ARTICLE III ADMINISTRATION

Section 2.A The Representative Assembly

- 1. District. A District shall consist of one or more barangays, municipalities, cities and provinces as determined by the Board Of Directors. Initially, each branch shall be considered a district. The Board of Directors may however further divide a district to several districts at its discretion. Likewise, as determined by the Board of Directors, The Main Office may be divided into North District, South District, East District, West District and/or such other districts, as the Board of Directors shall create and establish, which shall likewise include all the barangays, municipalities, cities and provinces within its jurisdiction. In all cases, a district must at least have a minimum of one thousand (1,000) Regular Members.
- 2. Quorum in a District Meeting. At least twenty five percent (25%) of the Regular Members who are bonafide residents of the barangays, municipalities, cities and provinces which are within the jurisdiction of a district shall constitute a quorum. Only Regular Members who are Members in Good Standing (MIGS) are entitled to vote. Eighty five (85) days before the date of the district election, no Regular Member is allowed to transfer to another district and to vote thereon.
- 6. Election of District Representatives. Regular District Meeting wherein the election of the District Representatives (DR) shall be conducted, may be held not later than sixty (60) days prior to the date of the Regular Annual Representative Assembly Meeting (ARAM). However, the Board of Directors at its discretion, shall set the date and time either simultaneously or sequentially, of each and every Regular District Meeting. The District Representative/s shall be elected by secret balloting during the Regular District Meeting by the Regular Members of the district, who are likewise Members In Good Standing.
- 7. Term of Office of a District Representative. The Term of Office of a District Representative shall be two (2) Years, Which shall commence on the first Regular Annual Representative Assembly Meeting. The Regular District Meeting wherein the election shall be conducted for all the various Districts Of Tagum Cooperative, an a particular date and time shall be determined by the Board Of Directors. No District Representative shall serve for more than three (3) Consecutive Terms. Moreover, each and every District Representative must maintain his/her monthly "MEMBER FOR TWELVE CONSECUTIVE MONTHS (MTCM)" status all throughout his/her Term Of Office
- 8. Failure of the District to elect District Representatives. In case the District failed to elect its District Representative/s during the Regular District Meeting wherein the election is conducted, the right to send its District Representative/s to a particular Representative Assembly Meeting shall be deemed waived, and such waiver shall be effective until the next regular district election. Hence, no District Election shall be conducted.
- 10. Any District Representative during a District Meeting called for the purpose, shall be removed by a vote of three-fourths (3/4) of the entire Regular Members who are Members In Good Standing present and constituting a quorum, on the following grounds:
- A) Failure to attend the immediate preceding Representative Assembly Meeting for unjustifiable reason;
- B) non-performance of any functions and responsibilities stated in the by-laws;
- C) Any Violation of the provisions of RA 9520, the By-Laws of Tagum Cooperative and other issuances of the Cooperative Development Authority (CDA);
- D) Any acts or omissions inimical or prejudicial to the Interest of Tagum Cooperative.

During the same District Meeting, The district shall fill the vacancy caused by the removal, resignation, incapacity or death of the District Representative. This Provision shall likewise apply, in the event vacancy occurs, in the Office of the District Election Deputies (DED) and in the Office of the Lead District Representative (LDR).

13. District Meeting. The District Meeting shall be as follows:

A) Regular. The Regular District Meeting shall be conducted to elect by secret balloting the District Representatives (DR) and the District Election Deputies (DED), which election shall be given utmost priority. However, after the election shall have been conducted and finally completed, other matters as presented by the Lead District Representative and/or by the Regular Members who are MIGS, which are relevant, important and beneficial to the interest of Tagum Cooperative in general and the members of the district in particular, may be considered. Only Regular Members Who Are MIGS shall vote, be voted upon and deliberate thereon.

Section 9. Powers and Duties of the Board of Directors

4. It shall have the authority to appoint the Treasurer and the Secretary of the Board of Directors. It shall likewise create committees and convene the Joint Officials Meeting in aid of its supervision and control of the affairs of Tagum Cooperative and the formulation of policies. Corollary thereto, it shall appropriate funds for this purpose.

Section 10. Qualification and Disqualification for Directors

All Regular Members in Good Standing who have fully paid six (6) months prior to the date of filing the Certificate of Candidacy as minimum amount of Share Capital required of Elective Officers, as determined by the Representative Assembly from time to time by Means of Resolution, who have the time, are willing to serve and must have been Director, Secretary of the Board of Directors, Treasurer, Members of the Education Committee (EdCom), Supervisory Audit and Inventory Committee (AC) (SAIC), Credit Committee (CreCom) or Election Committee (EleCom) of Tagum Cooperative or any duly registered Savings and Credit Cooperatives as certified to and accredited as a Cooperative-In-Good Standing by the Cooperative Development Authority (CDA) for at least three (3) aggregate years prior to the Date of Election, are qualified to be voted upon as Directors.

At least sixty percent (60%) which is the majority, of the Members of the Board of Directors of Tagum Cooperative must come from Tagum City and the rest may come from the other municipalities, cities and provinces within the area of operation of Tagum Cooperative. All members of the Board of Directors shall be elected at large by the MIGS, except the following:

- a. Those holding any elective and /or appointive positions in the government that are political in nature;
- $\ \, \text{b. Those having conflicting interest with the business of Tagum Cooperative};$
 - Those who are directly or indirectly involved in the business of lending money to other persons;
 - Those who are stockholders/investors of corporations, directors, officers and employees of banks or other similar lending institutions except where Tagum Cooperative is a member or a stockholder or depositor;
 - 2.a Those who are directors and officers in their individual capacity and employees of banks or other institutions having similar business with Tagum Cooperative including primary cooperatives.
- c. Those who, during their incumbency, had been absent for three (3) consecutive regular Board of Directors' Meetings without being excused. BOD Recording-Secretary/BOD Secretary shall provide EleCom all the documents without being asked by EleCom with respect to any unexcused absences of an incumbent Director:

E) Whenever the Term of Office of a District Representative has expired, or he/she has resigned, incapacitated or has been removed by his/her district as District Representative, his/her term of office as incumbent member of the Board Of Directors, the Audit Committee or the Election Committee shall likewise cease. The provisions of the preceding paragraphs "11.A" and "11.B", shall likewise apply, whichever is/are applicable, in filling such vacant position.

During the same District Meeting, The district shall fill the vacancy caused by the removal, resignation, incapacity or death of the District Representative and, his/her term of office as incumbent member of the Board Of Directors, the Audit Committee or the Election Committee Shall Likewise Declared Vacant.

13. District Meeting. The District Meeting shall be as follows:

A) Regular. The Regular District Meeting shall be conducted to elect by secret balloting the District Representatives (DR) which election shall be given utmost priority. However, after the election shall have been conducted and finally completed, other matters as presented by the Lead District Representative and/ or by the Regular Members who are MIGS, which are relevant, important and beneficial to the interest of Tagum Cooperative in general and the members of the district in particular, may be considered. Only Regular Members who are MIGS shall vote and deliberate thereon.

Section 9. Powers and Duties of the Board of Directors

4. It shall have the authority to appoint the Treasurer and the Secretary of the Board of Directors and Honorary Members of the Board who will be chosen from the Past Officials and/or members who have the technical expertise in running a cooperative in aid of decision-making but without voting right. It shall likewise create committees and convene the Joint Officials Meeting in aid of its supervision and control of the affairs of Tagum Cooperative and the formulation of policies. Corollary thereto, it shall appropriate funds for this purpose.

Section 10. Qualification and Disqualification for Directors

All District Representatives who have fully paid the minimum amount of Share Capital for six (6) months prior to the date of filing of the Certificate of Candidacy being required of Elective Officers, as determined by the Representative Assembly from time to time by Means of Resolution, who have the time, are willing to serve and must have been Director, Secretary of the Board of Directors, Treasurer, Members of the Education Committee (EdCom), Audit Committee (AC), Credit Committee (CreCom), Election Committee (EleCom), Mediation and Conciliation Committee or Ethics Committee of Tagum Cooperative or any duly registered Savings and Credit Cooperatives as certified to and accredited as a Cooperative-In-Good Standing by the Cooperative Development Authority (CDA) for at least three (3) aggregate years prior to the Date of Election, are qualified to be voted upon as Directors.

At least sixty percent (60%) which is the majority, of the Members of the Board of Directors of Tagum Cooperative must come from Tagum City and the rest may come from the other municipalities, cities and provinces within the area of operation of Tagum Cooperative. All members of the Board of Directors shall be elected at large by the MIGS, except the following:

a. Those who, during their incumbency, had been absent for three (3) consecutive regular Board of Directors' Meetings without being excused. BOD Recording-Secretary/BOD Secretary shall provide EleCom all the documents without being asked by EleCom with respect to any unexcused absences of an incumbent Director:

- d. Full-time employee of Tagum Cooperative;
- e. Those convicted of any crime involving moral turpitude, gross negligence or gross misconduct in the performance of their duties or are found culpable in any administrative case involving such offenses;
- f. Those who were convicted by final judgment relative to anomalies or irregularities or wrongful acts involving financial and/or property accountability in any establishment:
- g. Those who are disqualified pursuant to the disqualification prescribed by the proper government agency;
- h. Those who have relatives within the fourth civil degree of consanguinity or affinity who are working as contractual, probationary or regular employees of Tagum Cooperative;
- Those who are relatives of an incumbent member of the Board of Directors or any incumbent elected or appointed committee member or officer within the 4th civil degree of affinity or consanguinity;
- j. Those running as candidates for the Board of Directors or any elective position who are relatives within the 4th civil degree of affinity or consanguinity, only one shall be allowed to file a Certificate of Candidacy;
- k. Those who have been expelled/terminated and/or have withdrawn their membership from Tagum Cooperative.
- Those employees who had been terminated for cause are permanently disqualified to run for the Board of Directors;
- m. Those whose property/ies whether paraphernal or conjugal had been foreclosed by Tagum Cooperative;
- n. Those who are business partners or associates in the practice of the same profession, who by their established actions or decisions proved to be detrimental to Tagum Cooperative;
- Those who have business transactions or employment with any coop federation or any apex coop organization or any business entity having business with Tagum Cooperative;
- p. Those employees who had either resigned or retired from the employment of Tagum Cooperative within two (2) years from separation, except due to coop's reorganization, personnel streamlining or organizational redundancy;
- q. Staff of any coop federation or any coop apex organization where Tagum Cooperative is an affiliate are disqualified from running for the Board of Directors:

Section 12. Election of Directors

The Board of Directors consisting of seven (7) members shall be elected by secret ballot by the members-in-good-standing at the Representative Assembly and shall hold office for a term of two (2) years unless earlier removed for cause or have resigned or become incapacitated due to illness or death and until their successors shall have been elected, qualified and have discharged the duties of the office, provided that at any given time, at least a seat for each gender shall be allotted in the Board of Directors, provided further, that during the election at the first Annual Representative Assembly after registration, four (4) of the Directors obtaining the highest votes ranked according to the highest number of votes obtained shall serve for two (2) years and the three (3) other Directors for one (1) year. Thereafter, all shall be elected for a term of two (2) years. However, no Director shall serve for more than three (3) consecutive terms.

Section 13. Vacancies

f. In the event there are vacancies in the elective committees, within ten (10) days from the occurrence of such vacancies, the same shall be filled by the remaining committee members, constituting a quorum, or if no quorum the Board of Directors shall elect or appoint member/s-in-good-standing to fill the vacancies. The successors named in the above-mentioned offices shall serve for the unexpired portion of the term. However, this provision is subject to Section 11 and its sub-paragraphs except sub-paragraph (c) thereof of Article III and subject furthermore to Section 16 (A) in the case of the Election Committee; to Section 17 sub-paragraph (a) in the case of the Audit Committee.

Section 15 B. Powers and Jurisdiction of the Election Committee

 a. The Election Committee shall have the sole authority to conduct, supervise and manage any and all elections and shall likewise exercise such powers

- Those who are relatives of an incumbent member of the Board of Directors or any incumbent elected or appointed committee member or officer within the 4th civil degree of affinity or consanguinity;
- c. Those running as candidates for the Board of Directors or any elective position who are relatives within the 4th civil degree of affinity or consanguinity, only one shall be allowed to file a Certificate of Candidacy;
- d. Those whose property/ies whether paraphernal or conjugal had been foreclosed by Tagum Cooperative;
- e. Those who are business partners or associates in the practice of the same profession, who by their established actions or decisions proved to be detrimental to Tagum Cooperative;
- f. Those who have business transactions or employment with any coop federation or any apex coop organization or any business entity having business with Tagum Cooperative;
- g. Those employees who had either resigned or retired from the employment of Tagum Cooperative within two (2) years from separation, except due to coop's reorganization, personnel streamlining or organizational redundancy;
- h. Staff of any coop federation or any coop apex organization where Tagum Cooperative is an affiliate are disqualified from running for the Board of Directors:

Section 12. Election of Directors

The Board of Directors consisting of **nine (9)** members shall be elected by secret ballot by the members-in-good-standing at the Representative Assembly and shall hold office for a term of two (2) years unless earlier removed for cause or have resigned or become incapacitated due to illness or death and until their successors shall have been elected, qualified and have discharged the duties of the office, provided that at any given time, at least **two (2)** seats for each gender shall be allotted in the Board of Directors, provided further, that during the election at the first Annual Representative Assembly after registration, four (4) of the Directors obtaining the highest votes ranked according to the highest number of votes obtained shall serve for two (2) years and the three (3) other Directors for one (1) year. Thereafter, all shall be elected for a term of two (2) years. However, no Director shall serve for more than three (3) consecutive terms.

Section 13. <u>Vacancies</u>

f. In the event there are vacancies in the elective committees, within ten (10) days from the occurrence of such vacancies, the same shall be filled by the remaining committee members, constituting a quorum, or if no quorum the Board of Directors shall elect or appoint member/s-in-good-standing to fill the vacancies. The successors named in the above-mentioned offices shall serve for the unexpired portion of the term. However, this provision is subject to Section 11 and its sub-paragraphs except sub-paragraph (c) thereof of Article III and subject furthermore to Section 15 (A) in the case of the Election Committee; to Section 16 sub-paragraph (a) in the case of the Audit Committee.

Section 15 B. <u>Powers and Jurisdiction of the Election Committee</u>

 a. The Election Committee shall have the sole authority to conduct, supervise and manage any and all elections and shall likewise exercise such powers

and authorities as provided in paragraphs "l.", "n.", "o.", "p.", "r.", "s." and "z." of Section 15, Article III of these By-laws.

- b. In the conduct, supervision and management of all elections in Tagum Cooperative, the Election Committee shall exercise, but not limited to, the following powers:
 - (1) To deputize any qualified member of Tagum Cooperative;
 - (2) To promulgate rules and regulations for the conduct of a clean, orderly, honest and inexpensive election;
 - (3) To pass upon the qualifications of all candidates in accordance with the By-Laws, rules and regulations and policies approved by the Board of Directors or the Representative Assembly;
 - (4) To have the sole authority to hear and decide all election protests; and
 - (5) To hear and decide all cases involving elective officials.
- c. In consonance thereto, all candidates must submit to the Election Committee their Certificates of Candidacy, under oath, sixty-five (65) days before Election Day. Fifty-five (55) days before the date of election, the Election Committee shall post the names of the candidates on the bulletin board of Tagum Cooperative. Within seven (7) days after posting, any member in good standing may file a pre-election protest in writing and under oath with the Election Committee concerning the qualification or disqualification of any candidate.

If no pre-election protest shall have been filed during the said seven (7) day period, the decision of the Election Committee regarding the qualification or disqualification of any candidate shall become final and executory and the names of the candidates so posted by the Election Committee shall become the final list of candidates qualified to run for the different vacant offices in the Tagum Cooperative. However, if within the said period of seven (7) days, a pre-election protest has been filed, the Election Committee shall resolve the same within seven (7) days after the receipt by Election Committee of all pleadings and documentary and testimonial evidence. (Refers to the rules and procedure Voluntary Waiver)

Likewise within seven (7) days after receipt of the resolution/order of the Election Committee, any party directly affected by such decision may appeal to the General Assembly on the day of election by filling a notice of appeal and stating therein the reasons/grounds for the appeal with the Secretary of the Election Committee and such appeal shall be resolved, immediately preceding the presentation of candidates and the decision of the General Assembly is final.

- d. The Election Committee shall require the Board of Directors to submit to the Election Committee thirty (30) days before the date of the Annual Representative Assembly Election, a certified list of all members in good standing. This certified list of all members in good standing shall likewise be posted by the Board Secretary on the bulletin board of Tagum Cooperative and other conspicuous places in the area of operation of the Tagum Cooperative within three (3) days after the submission of the certified list to the Election Committee.
- e. Any member who wishes to be included in the said certified list of all members in good standing shall file with the Board of Directors, through the Secretary, a petition for inclusion in the aforesaid list of members in good standing within five (5) days before the election day. The inclusion of the name of members in such list shall not be a bar to the filing of any disqualification suit involving candidates.
- f. The Board of Directors shall immediately decide all petitions for inclusion. In the event that the Board of Directors fails to come up with a decision, the petition for inclusion is deemed approved if the only ground for his/her non-MIGS is his/her non-payment of all his/her past due and outstanding obligations provided however, that petitioner has fully paid all his/her said obligations on the date of the filling of the petition. In the event that the petitioner is a member of the Board of Directors, the petition shall be decided by the Election Committee.
- g. The campaign period shall commence thirty (30) days before the date of election and shall end a day before election date, however, no candidate shall be allowed to campaign if he had not attended the briefing/orientation conducted by the Election Committee for all candidates, which briefing shall be held by the Election Committee before the campaign period shall start. Any candidate who fails to attend such briefing/orientation without valid cause shall be disqualified to run as candidate. Such valid cause shall be determined by the Election Committee.
- Post-election protests on the ground of election irregularities, such as vote buying, fraud, harassment and similar acts and violations of campaign rules and regulations shall be filed within three (3) days from the date of election.

- and authorities as provided in paragraphs "l.", "n.", "o.", "p.", "r.", "s." and "z." of Section 14, Article III of these By-laws.
- b. In the conduct, supervision and management of all elections in Tagum Cooperative, the Election Committee shall exercise, but not limited to, the following powers:
 - (1) To promulgate rules and regulations for the conduct of a clean, orderly, honest and inexpensive election:
 - (2) To pass upon the qualifications of all candidates in accordance with the By-Laws, rules and regulations and policies approved by the Board of Directors or the Representative Assembly;
 - (3) To have the sole authority to hear and decide all election protests; and
 - (4) To hear and decide all cases involving elective officials

Sub-paragraphs c, d, e, f, g, h and i under SECTION 15 B. <u>Powers and Jurisdiction of the Election Committee</u> shall form part of the Tagum Cooperative Election Code.

The winning candidate shall be proclaimed by the Election Committee four (4) days after the date of the election. However, if there are protests, the Election Committee shall resolve all protests within the period of ninety (90) days from receipt by the Election Committee of all pleadings and documentary or testimonial evidence relative thereto.

i. The decision of the Election Committee on post-election protest may be appealed to the Cooperative Development Authority within fifteen (15) days from receipt of the decision by the affected party. In the event that the CDA fails to act on the appeal within 30 days from receipt thereof, shall render the decision of the Election Committee as final and executory.

Section 15 C. Restrictions

- a. Printed handbills with a maximum dimension of four (4) inches by six (6) inches, or one-fourth size of a long bond/mimeo paper is allowed. Only the name of the candidate and the office, under which he is seeking election including his biodata, picture and election platform, shall appear. Any fraudulent statement or information printed in the handbill as to qualification, achievement, educational attainment, awards and recognition received and similar material information or statement shall be a ground for disqualification of the said candidate.
- On Election Day, no handbills shall be distributed or posted within the radius
 of ten (10) meters from the assembly area and within the assembly area except
 posters or streamers of the Election Committee.
- c. The Election Committee or its deputies shall have the power to confiscate handbills or any election paraphernalia that do not follow the specifications herein mentioned.
- d. The use of print media, television, radios or other similar medium of advertisement is strictly prohibited.
- The giving of money, foods, drinks, unauthorized handbills and other propaganda
 materials to a member or voter by a candidate or his representatives during the
 campaign and, on or before Election Day is likewise prohibited.
- f. T-shirts, personalized calendars, fans, bookmarks, hats and other similar devices used for campaign gimmicks shall be likewise prohibited.
- g. The Election Committee shall cause the printing of the common election campaign materials, which shall be distributed together with the Notice of the Representative Assembly and/or such other means as the Election Committee shall deem fit and advisable.
- h. Violation of any of the foregoing restrictions shall be ground for disqualification and/or removal from office of the said candidate/official.
- The act of a candidate or of his/her supporters in providing vehicles or any mode of transportation to voters and/or in paying the transportation expenses of voters in going to and/or from the venue of election or general assembly on the date of election is strictly prohibited.

Section 15 D. Prohibition on Employees

- a. All employees of Tagum Cooperative are prohibited from campaigning directly or indirectly for/or against any candidate. Any employee violating this provision shall be penalized in the manner herein below provided:
 - First offense, warning or reprimand;
 - Second offense, ninety (90) working days suspension from work without pay;
 - (3) Third offense, termination from employment and forfeiture of all his benefits
- This provision applies also to any employee who is on leave or under suspension.

Section 15 E. Independence of the Election Committee

The Article III-Administration, Section 15.C. Restriction shall form part in the Tagum Cooperative Election Code.

The Article III-Administration, Section 15.D. Prohibition on Employees shall form part in the Tagum Cooperative Ethics and HRD Manuals.

Section 15 C. Independence of the Election Committee






